Welcome to PrideMajic. PrideMajic.com is a division of 2Dudes1Dream LLC ("Pride Majic," "we," "our," or "us"). These Terms of Service ("Terms") govern your access to and use of PrideMajic.com, our online store, products, custom printing and design services, print-on-demand services, wholesale or business services, and other services that link to these Terms.

By visiting our website, creating an account, submitting an order, requesting custom work, or otherwise using our services, you agree to these Terms and to any policies referenced in them. If you do not agree, please do not use our website or services.

These Terms are intended to work together with our Privacy Policy, Shipping Policy, Return/Refund Policy, and any written quote, invoice, statement of work, wholesale agreement, print-on-demand agreement, or other contract that applies to a specific project. If a signed or separately agreed written contract conflicts with these Terms, the specific contract controls for that project.

1. Eligibility and Acceptance

You may use our website and services only if you can legally enter into a binding agreement. If you are under 18, you may use our services only with the involvement and consent of a parent or legal guardian.

You agree to use our website and services only for lawful purposes, to provide accurate and complete information, and to keep your account and contact information current.

2. Products, Made-to-Order Items, and Product Variations

Many Pride Majic products are produced or decorated after an order is placed. Product images, mockups, color swatches, and size information are provided to help you make a selection, but small variations may occur between what appears on a screen and the finished product.

Reasonable variations in garment color, print color, print placement, texture, dimensions, and manufacturer sizing are not considered defects when they fall within normal production tolerances. Please review product descriptions and size information carefully before ordering.

3. Orders, Pricing, and Payment

By placing an order, you are offering to purchase the selected products or services at the prices and terms shown at checkout or stated in an approved quote or invoice. All orders are subject to acceptance by Pride Majic.



- **Payment methods:** We accept the payment methods displayed at checkout or stated on an invoice. Payments may be processed by third-party payment providers.
- **Prices and taxes:** Prices are shown in U.S. dollars unless otherwise stated. Applicable sales tax, shipping, duties, or other charges may be added when required.
- **Authorization:** You represent that you are authorized to use the payment method submitted with your order.
- **Errors:** We may correct pricing, description, inventory, or technical errors and may cancel or refuse an order when reasonably necessary. If we cancel an order after payment has been collected, we will refund the amount paid for the canceled item or service.

4. Order Changes and Cancellations

Because many items are made-to-order and may enter production quickly, an order may not be changeable or cancelable after it is submitted. If you notice an error, contact us as soon as possible. We will try to help when production status allows, but we cannot guarantee that a change or cancellation can be made.

For custom, bulk, wholesale, design, or print-on-demand work, any cancellation rights, deposits, setup fees, design fees, production charges, or non-refundable amounts stated in a quote, invoice, or project agreement will also apply.

5. Custom Artwork, Personalization, and Customer-Supplied Content

When you provide artwork, logos, photographs, names, text, trademarks, designs, or other materials for a custom order ("Customer Content"), you represent that you own the content or have all permissions needed for Pride Majic to reproduce, modify, print, display, or otherwise use it for the requested project.

You grant Pride Majic a limited license to use Customer Content as reasonably necessary to prepare proofs, produce the order, provide customer service, maintain production records, and fulfill the requested services. We may refuse content that we reasonably believe is unlawful, infringing, fraudulent, threatening, or otherwise inappropriate for production.

Unless a separate written agreement says otherwise, ownership of original artwork, templates, production files, concepts, or design elements created by Pride Majic remains with Pride Majic or 2Dudes1Dream LLC. Paying for a finished product or design service does not automatically transfer copyright or ownership of source files.

6. Proofs and Customer Approval

When a proof or mockup is provided for approval, you are responsible for reviewing spelling, names, dates, colors, layout, sizing, artwork, and other requested details before approving production. Approval authorizes us to proceed based on the approved proof. Changes requested after approval may result in additional charges, delays, or the need to produce a new item.

7. Shipping, Delivery, and International Orders

We ship to the destinations and by the methods offered at checkout or agreed for a project. Processing and delivery estimates are estimates, not guarantees. Shipping carriers are independent third parties, and delays can occur after an order leaves our possession.



- **Shipping address:** You are responsible for providing a complete and accurate delivery address. Additional charges may apply if a package must be re-routed or re-shipped because of an incorrect address.
- **Carrier events:** We are not responsible for carrier delays, weather disruptions, delivery interruptions, theft after confirmed delivery, or other events outside our reasonable control, although we will assist with a carrier claim when appropriate.
- **International orders:** Customers are responsible for customs duties, import taxes, brokerage fees, or other government charges unless we expressly state otherwise.

8. Returns, Refunds, and Damaged or Defective Items

Because most Pride Majic products are made-to-order, personalized, or produced specifically for the purchaser, sales are generally final except when an item arrives damaged, defective, incorrect because of our production error, or is otherwise eligible under our posted Return/Refund Policy.

If there is a problem with an order, contact us within the timeframe stated in the applicable Return/Refund Policy and provide the information reasonably needed to review the issue, such as the order number and photographs. Nothing in these Terms limits any rights you may have under applicable consumer protection law.

9. Business, Wholesale, Fundraising, and Print-on-Demand Services

Pride Majic may provide services to businesses, nonprofits, teams, performers, organizations, and other clients, including custom apparel, wholesale production, fundraising stores, and print-on-demand storefronts. These services may have additional pricing, minimums, setup fees, production requirements, payout terms, artwork rules, exclusivity terms, or other conditions stated in a quote, invoice, proposal, or separate agreement.

If a separate agreement applies to a business or print-on-demand relationship, that agreement controls to the extent it conflicts with these general Terms.

10. Intellectual Property

The PrideMajic.com website and its original content - including Pride Majic names, logos, graphics, photographs, product designs, illustrations, text, page layouts, and other materials - are owned by or licensed to 2Dudes1Dream LLC and are protected by copyright, trademark, and other intellectual property laws.

Except for normal personal use of the website, you may not copy, reproduce, republish, distribute, modify, create derivative works from, sell, license, scrape, or commercially exploit our content without prior written permission. Rights in third-party trademarks, artwork, or licensed content remain with their respective owners.

11. Acceptable Use and User Conduct

You agree not to misuse our website or services. Prohibited conduct includes:

- Using the website or services for unlawful, fraudulent, abusive, or harmful activity.
- Attempting to gain unauthorized access to accounts, systems, data, or networks.
- Introducing malware, automated attacks, or code intended to disrupt or damage the website.
- Impersonating another person or submitting false or misleading information.



- Using automated tools to scrape, harvest, or copy website content in a manner that interferes with our services or violates applicable law.
- Submitting Customer Content that infringes another person's intellectual property, privacy, publicity, or other legal rights.

12. Accounts and Account Security

If you create an account, you are responsible for maintaining the confidentiality of your login credentials and for activity conducted through your account. Please notify us promptly if you believe your account has been accessed without authorization. We may suspend or terminate accounts that are used fraudulently or in violation of these Terms.

13. Third-Party Services and Links

Our website may use or link to third-party services such as payment processors, shipping carriers, social media platforms, analytics providers, or other websites. We do not control third-party services and are not responsible for their availability, content, security, or practices. Your use of third-party services may be subject to their own terms and privacy policies.

14. Website Availability and Disclaimer of Warranties

We work to keep PrideMajic.com accurate and available, but we do not guarantee that the website will always be uninterrupted, error-free, or free of harmful components. To the fullest extent permitted by law, the website and services are provided on an "as available" and "as is" basis, except for any express warranty or consumer right that cannot legally be excluded.

We do not make guarantees regarding a particular business outcome, fundraising result, resale performance, audience response, or other result from the use of our products or services.

15. Limitation of Liability

To the fullest extent permitted by applicable law, Pride Majic and 2Dudes1Dream LLC will not be liable for indirect, incidental, special, exemplary, punitive, or consequential damages, including lost profits, lost revenue, lost data, or loss of business opportunity, arising from or related to the website, products, shipping, or services.

To the fullest extent permitted by law, our total liability for a claim relating to a particular product, order, or service will not exceed the amount you paid to Pride Majic for the product, order, or service giving rise to the claim. Some jurisdictions do not allow certain limitations, so some of these limitations may not apply to you.

16. Indemnification for Misuse or Customer Content

To the extent permitted by law, you agree to be responsible for claims, losses, or expenses arising from your unlawful misuse of our services or from Customer Content you submit without the rights or permissions required by these Terms. This provision does not require a consumer to indemnify Pride Majic for our own negligence or conduct where such a requirement is prohibited by law.

17. Suspension or Termination

We may suspend or terminate access to our website or services, cancel an order, or refuse future service when reasonably necessary to address fraud, nonpayment, abuse, security concerns, unlawful activity, repeated violations of these Terms, or other conduct that creates material risk to Pride Majic, our customers, or third parties.



18. Governing Law and Disputes

These Terms are governed by the laws of the State of Minnesota, without regard to conflict-of-law principles, except where applicable consumer law requires otherwise. To the extent permitted by law, disputes that are not resolved informally will be brought in a state or federal court with jurisdiction in or serving Ramsey County, Minnesota. Nothing in this section limits rights or remedies that cannot legally be waived.

19. Changes to These Terms

We may update these Terms from time to time to reflect changes in our services, business practices, or legal requirements. The revised Terms will be posted on PrideMajic.com with an updated "Last Updated" date. Changes apply prospectively unless otherwise stated or required by law. Your continued use of our website or services after updated Terms become effective constitutes acceptance of the revised Terms.

20. Severability, Waiver, and Entire Agreement

If any provision of these Terms is found unenforceable, the remaining provisions will remain in effect to the fullest extent permitted by law. Our failure to enforce a provision is not a waiver of that provision. These Terms, together with the policies and specific agreements referenced above, form the agreement between you and Pride Majic regarding the services they cover.
